

### 1. Agreement

This is an Agreement between You ('You' includes any additional renters and any authorised drivers identified in Rental Vehicle Agreement Part A) and Cheapa Campa Ltd ('Cheapa Campa'), to rent the Vehicle identified in Rental Vehicle Agreement Part A including all its accessories, tools, tyres and equipment as well as any replacement vehicle. This Agreement (including any addendum or memorandum) shall be read and construed in its entirety and shall constitute the entire agreement between Cheapa Campa and You and shall supersede all other provisions, terms, warranties or conditions contained in any other agreement, brochure, promotion, website advertisement or any other document. This Agreement shall be governed in accordance with the laws of the State of Queensland in the Commonwealth of Australia. Any actions. claims, demands or suits arising out of or in respect of this Agreement must be brought in the courts in Brisbane, Queensland.

# 2. Refusal of Rental

Cheapa Campa reserves the right to refuse any rental, or continuation of any rental, at its absolute discretion.

# 3. Vehicle Condition and Return

- You acknowledge the Vehicle was delivered to You by Cheapa Campa in good operating condition and with the seal of the odometer unbroken. You (a) agree to return the Vehicle without alteration or addition to the Vehicle and in the same condition (except for ordinary wear and tear) together with all tools, tyres, accessories and equipment to the Return Location on the Return Date specified in Rental Vehicle Agreement Part A or sooner if demanded by Cheapa Campa.
- You acknowledge that the Vehicle is the sole property of Cheapa Campa and that at the time of receipt of the Vehicle by You it was in good running (b) condition and fit for the purpose for which You required it and You ascertained this on your own inspection of the Vehicle and not as a result of any representation made by Cheapa Campa, its employees or agents.
- You acknowledge that the only existing damage to the Vehicle at the commencement of this Agreement is that detailed on the Vehicle (c) Condition Report. It is essential that all existing damage is noted by You on the Vehicle Condition Report. Any damage which has not been noted on the Vehicle Condition Report will constitute damage which has occurred subsequent to the commencement of this Agreement for which You shall be charged.
- (d) Cheapa Campa in its absolute discretion may take possession of the Vehicle without prior demand to You, and at your expense, if there has been a breach of any term of this Agreement or if the Vehicle is illegally parked, used in violation of any law or is apparently abandoned. In such circumstances Cheapa Campa, its employees or agents may enter on any property where the Vehicle is situated and You will indemnify Cheapa Campa, its employees and agents from claims by any person resulting from such entry and retaking of the Vehicle.
- (e) If the seal of the odometer is broken or otherwise tampered with, You will be responsible for not only an extra charge based on 500 kilometres per day at 50c per kilometre, but also for any costs of repairing or replacing the odometer.
- If You fail to return the Vehicle to the Return Location or return the Vehicle (f) to a different location to the Return Location, You will be charged for all costs associated with transporting or towing the Vehicle to the Return Location plus a minimum relocation charge of \$700 unless otherwise agreed by Cheapa Campa in writing. If You attempt to return the Vehicle to the Return Location and it is not open
- (g) for business at the time You return the Vehicle, the Vehicle will be deemed to have been returned at the time when that Return Location next opens for business and the rental shall continue until that time and You shall remain fully responsible for the Vehicle, unless other arrangements have been agreed to in writing by Cheapa Campa.
- You must only use the fuel specified by the manufacturer of the Vehicle. Using bio-diesel, ethanol or any organic hybrid fuel is strictly considered (h) the wrong fuel type. All costs associated with the use of this fuel including contaminated fuel will be at Your sole expense.

Cheapa Campa must be notified and it must agree to any extension of the rental period beyond that specified in Rental Vehicle Agreement Part A prior to the return date for the Vehicle otherwise the Vehicle will be immediately reported to the police as stolen.

# 4. Unauthorised and Prohibited Use of Vehicle

Persons who must not drive the Vehicle

#### A person who is not identified in Rental Vehicle Agreement Part A as (a) either the renter or authorised driver.

- A person who is not licensed for that class of Vehicle. (b)
- A person whose blood alcohol concentration exceeds the lawful (c) percentage whilst driving the Vehicle
- A person who was driving the Vehicle whilst under the influence of a drug. A person who has given or for whom You have given a false name, age, (d) (e)
- address or driver's licence details. (f) A person whose driver's licence has been cancelled, endorsed or
- suspended within the last two years. A person who has held a full open driver's licence for less than two vears.
- (g) (h) A person under 21 years of age.
- A person who uses or intends to use the Vehicle for any illegal purpose. Circumstances where the Vehicle must not be used:
- Any area outside the Area of Travel shown in Rental Vehicle Agreement (a)
- Part A. Any area where applicable travel restrictions of clause 12 of this Agreement (b)
- apply or unless authorised by Cheapa Campa in writing. Carrying persons for hire, gain or reward, or to carry any inflammable, (c)
- explosive or corrosive materials. Pushing or towing any Vehicle, trailer, boat or other object unless (d)
- authorised by Cheapa Campa in writing. Carrying any greater load and/or more persons and/or for a purpose for which the Vehicle is designed and constructed. (e)
- Using the Vehicle for racing, pacemaking, reliability trials, speed trials, hill climbing or being tested in preparation for those activities. (f)
- Using the Vehicle in a dangerous, wilful or reckless manner (g)
- (h) Using the Vehicle in contravention of any legislation or regulation controlling vehicular traffic.
- (i) Carrying any animal in the Vehicle, unless authorised in writing by Cheapa Campa
- (j) Carrying illegal substance or product.

#### Vehicle not to be used for commercial use or financial gain. 5. Financial Obligations

You and any additional renter/s and/or authorised driver/s are jointly and severally responsible for compliance with the terms of this Agreement. By entering into this Agreement You and any additional renter/s and/or authorised driver/s are responsible for and irrevocably authorise Cheapa Campa to debit the credit card/s provided (and You will pay Cheapa Campa, on demand, any balance) with the following charges:

- The rental charges specified in Rental Vehicle Agreement Part A. All charges claimed from Cheapa Campa for toll, parking and/or any other (b) traffic violations incurred during the rental period or until such later time as the Vehicle is returned to Cheapa Campa. An additional administration fee of \$75 per fine / infringement will apply to cover the costs of processing.
- (c) All loss of or damage to the Vehicle, (including the loss of use of that Vehicle - 'demurrage'), legal expenses, assessment fees, towing and recovery costs, third party damage, storage and other charges rendered by Cheapa Campa's where:
  - You have breached any term of this Agreement ;
  - (ii) You have left the Vehicle unlocked or left the keys in the Vehicle;
  - You have not kept the keys secure and under your personal control; (iii)
  - You have lost, damaged or had the keys stolen; (iv) The Vehicle is totally or partially immersed in any water regardless (v) of cause;
  - (vi) The interior of the Vehicle is damaged regardless of cause except when there is a collision with another vehicle;
  - (vii) The tyres of the Vehicle are damaged other than by normal wear and tear except where You have purchased Liability Reduction and it applies;
  - (viii) You have failed to maintain all fluid and fuel levels of the Vehicle or failed to immediately rectify or report to Cheapa Campa any defect in the Vehicle of which You become or ought to have become aware
  - (ix) The Vehicle is damaged by loading or unloading, normal wear and tear excepted;
  - The underbody and/or overhead of the Vehicle is damaged (x) regardless of cause except where You have purchased 4WD Camper Bonus Pack and it applies or there is a collision with another Vehicle;
  - You have been deemed negligent in any action thereby resulting in (xi) damage to the Vehicle or third party property;
  - You have damaged the Vehicle by any wilful or reckless misconduct; Damage is caused by sitting or standing on the bonnet or roof of the (vii) (xiii)
  - vehicle Damage is caused to the Vehicle whilst it is being transported over (xiv)
  - water; (xv) Damage is caused to the Vehicle whilst it is being loaded or unloaded on a watercraft and/or tow truck:
  - Damage is caused to the Vehicle by snow chains: (xvi)
  - (xvii) Damage is caused to the awning of the Vehicle or where You have purchased 4WD Camper Bonus Pack and it applies. A minimum fee of \$1500 will apply per awning damage;
  - (xviii) Damage caused by a single vehicle roll over;
  - (xix) Costs are incurred for recovering the Vehicle if it is bogged
  - (xx) Costs are incurred where the wrong fuel type or contaminated fuel was used or where water was put in the fuel tank;
  - (xxi) Costs are incurred where fuel was put in the water tank;
  - Costs are incurred with the Vehicle running out of fuel; (xxii)
  - (xxiii) Costs are incurred with losing the fuel, oil or water caps and items in
  - the convenience and/or camping kits; (xxiv) Costs associated with damage or accidents caused by falling asleep
  - whilst driving;

(xxv) Damage caused to the Vehicle by hitting a signed height restricted structure such as but not limited to bridges, car parks and drive throughs. We accept American Express, Visa, MasterCard, Visa Debit, MasterCard Debit and Diners Club. American Express and Diners Club will incur an additional non-refundable 4.5% surcharge on any transaction. Visa, MasterCard, Visa Debit and MasterCard Debit will incur an additional non-refundable 2% surcharge on any transaction. EFTPOS may be used to pay for rental charges

(not bonds). Cash will not be accepted under any circumstances. If You have paid by use of a credit card, or directed Cheapa Campa to bill the charges to some other person, corporation, firm or organisation who or which fails to make payment when due, You will immediately pay the full amount due to Cheapa Campa on demand.

You irrevocably agree and authorise Cheapa Campa to use the credit card/s provided for payment of any amount due under this Agreement even if a signed credit card voucher has been returned.

# 6. Cancellation Fees

There is no refund for late pick up or early return of the Vehicle All other cancellation fees are outlined in the Summary Rental Conditions.

# 7. Change of Vehicle

Should the Vehicle booked be unavailable for any reason, Cheapa Campa reserves the right to substitute an alternative vehicle without prior notification and at no extra cost to You. This shall not constitute a breach of contract and does not entitle You to a refund.

# 8. Voluntary Downgrade

Should You decide to take a lesser vehicle than the one booked You will not be entitled to a refund

# 9. Errors in Rental Charges

If Cheapa Campa has made a mistake in rendering charges to you in respect of the Vehicle You agree to pay any shortfall in charges to Cheapa Campa. 10. Exchange Rate/Currency Fluctuations/Refunds

You acknowledge that all transactions under this Agreement are conducted in Australian Dollars. Due to exchange rate fluctuations, there could be some variance between the amount initially debited against your credit card and the amount refunded at the expiration of the Rental Period. You irrevocably agree to release Cheapa Campa from any liability for such variation. Refunds by credit card including bond refunds can take up to 14 working days depending on the renter's Financial Institution.

### 11. Conditional Upon Payment

Where applicable, You agree that this Agreement is conditional upon Cheapa Campa being paid by the Travel Agent or Travel Wholesaler (Agent) who arranged this Agreement on your behalf. You will pay to Cheapa Campa, upon demand, any shortfall paid by You to the Agent and the amount that should have

been paid to Cheapa Campa based on the applicable standard gross rental rate in respect of the Vehicle for the rental period 12. Travel Restrictions

- Two Wheel Campervans & Motorhomes:-(a)
  - (i) Cannot be driven on any unsealed roads. The only exception is well maintained access roads less than 12 kilometres long to recognised campgrounds.
  - (ii) Can be driven to any island (including Tasmania) and /or North of the Daintree River as long as written permission is obtained from Cheapa Campa prior to travel. When travelling to these areas clause 12 (d) applies
- (b)
- (i) May be driven on unsealed roads on the sole condition that the roads driven on have been gazetted. Gazetted roads are roads that appear on official road maps and street directories
  - (ii) Can be driven to any island (including Tasmania, excluding Fraser Island and Moreton Island) as long as written permission is obtained from Cheapa Campa prior to travel. When travelling to these areas the conditions of clause 12 (d) apply. (iii) Cannot be driven on Fraser Island, Moreton Island, the Canning
  - Stock Route, The Lost City in Litchfield Park, Old Gunbarrel Highway, Gunbarrel Highway, the Old Telegraph Road section of the road to Cape York, Central Arnhem Road, Boggy Hole (Finke Gorge National Park), the Old South Road from Maryvale to Finke and the last 2 kilometres of the Lennard River Gorge Road, at any time. Vehicles are NOT permitted to travel to Cape York between the months of December to May (at all other times for travel to Cape York You, must call the Cheapa Campa Assist Department 24-48 hours prior to travel to a restricted area to request permission).
- Certain locations are considered unsafe to travel without taking some (c) important precautions such as determining road and weather conditions, hence travelling to these areas can only be with four wheel drive vehicles and You must obtain the written permission of Cheapa Campa prior to travel. When travelling to these areas the conditions of clause 12 (d) apply. These Areas include, but are not limited to Any Islands. Tasmania Simpson Desert, Bloomfield Track, North of Cape Tribulation, Oodnadatta Track, Birdsville Track, Tanami Track, Gibb River Road, Kalumburu Road as far as Drysdale Station, Warburton Road, Strzelecki Track, Cape Leveque, Bungle Bungles, the Plenty Highway, Burke Development Road from Chillagoe to Normanton and Savannah Way from Normanton to Borroloola, Finke Road, Arnnhem Land in general and any other remote
- In the event of an accident or breakdown in an area outlined in clause 12 (d) where this section (d) is mentioned it will be your full financial responsibility to pay any salvage, towing and/or recovery costs to the nearest Cheapa Campa branch (except where 4WD Camper Bonus Pack Cover has been purchased and applies). No replacement vehicle will be provided under any circumstances.
- Cheapa Campa reserves the right at its sole discretion to restrict vehicle (e) movements in certain areas for any reason including but not limited to adverse road or weather conditions.

#### 13. Every 500 kilometres

The oil, fluids and coolant levels must be checked by You every 500kilometres. You must add water/coolant to the cooling system and an appropriate Australian Society of Automotive Engineers rated oil for petrol or diesel powered vehicles (as applicable) to the engine if the indicator level is below minimum. You agree to maintain the Vehicle in these conditions and acknowledge that any mechanical damage occasioned as a result of your failure to maintain the Vehicle in accordance with this clause will be paid by You.

### 14. Mechanical Breakdowns

Any mechanical problems associated with the Vehicle must be reported to Cheapa Campa as soon as possible in order to give Cheapa Campa the opportunity to rectify the problem during the rental period. Equipment failure must also be reported to Cheapa Campa. If Cheapa Campa is either not contacted or You do not allow Cheapa Campa the opportunity to rectify the problem during the rental period You agree that the problem is of such a minor nature that You make no claim for loss of time in respect of the rental period. You also agree that Cheapa Campa is not responsible for any claims made by You after the return of the Vehicle. You will be charged a fee where it is established that roadside assistance could have been avoided in cases such as keys being locked in the Vehicle, flat batteries caused by lights having been left on and other such similar occurrences.

#### 15. Repairs

16. Tyres/Windscreens

Liability Reduction and it applies.

Any repair up to \$100 needs no authorisation from Cheapa Campa and all that is necessary for full reimbursement to You from Cheapa Campa is a proper receipt for the amount of the repairs. If the repair is more than \$100 then You must notify Cheapa Campa and obtain Cheapa Campa's consent before the repairs are carried out. If the Vehicle cannot be driven as a result of a breakdown, Cheapa Campa will only reimburse You for the time that the Vehicle was not available for use. Subject to availability, Cheapa Campa will provide a replacement vehicle. Any cost incurred in you travelling to a Cheapa Campa depot is your responsibility. The failure of accessories such as air-conditioners awnings, televisions, microwaves, stove and grill, water pump, camping kit items, shower and toilet, refrigerators and radios/cassettes/CD/DVD/video players are not considered a breakdown and no amount will be paid by Cheapa Campa to You. Cheapa Campa is not responsible for any accommodation charges, meals, change of itinerary or out of pocket expenses resulting from a breakdown of the Vehicle or as a result of any accident. Cheapa Campa is not responsible for any insect infestation such as but not limited to ants, flies, cockroaches, fleas, bedbugs and mosquitoes. Note: It can often be difficult to carry out repairs during weekends and holiday

periods and/or in remote areas due to limited opening times and/or spare parts.

Authorisation must be obtained from Cheapa Campa before tyres or windscreens can be replaced. You are responsible for replacing damaged

tyres (for example, but not limited to, blowouts, punctures, sidewall damage,

tyre staking etc) unless caused by normal wear. Maintain pressures as per the

Vehicle manufacturer's manual. Only purchase new steel radial tyres of the

same size and ply rating as is on the Vehicle. If You purchase tyres of a different size or ply rating Cheapa Campa will not refund You. You are responsible for

replacing damaged windscreens and tyres except where You have purchased

#### 17. Child Restraints

Cheapa Campa gives no warranty as to the appropriateness, correctness or adequacy of any child restraints fitted in the Vehicle and You accept full responsibility for the fitting and suitability of any such restraints fitted. 18. Accidents

In the event of an accident You must: (1) Record the Time/Date/Location:

- (2) Record the other parties full names, addresses, vehicle registrations, car types as well as any property damage in circumstances where the accident did not involve another motor vehicle;
- Record the name of their insurance company;
- Not admit liability: (4)
- (5) Notify the nearest police station within 24 hours of the accident;
- Fully complete and sign the Accident Report Form (located in the Vehicle) Notify Cheapa Campa within 24 hours of the accident and fax through the (6) (7) Accident Report Form.

In the event of an accident, the towing and retrieval of the Vehicle to the closest Cheapa Campa depot is at your expense up to the amount of your Liability Reduction where it applies or for the full amount where it doesn't apply. There is no refund for monies paid for the unused portion of the rental period. An administration fee of \$75 per accident file will apply (to cover the costs of processing). Replacement vehicle:

(1) Availability of a replacement vehicle is not guaranteed; provision is subject to availability, Your location, accident liability and remaining hire duration. Additional charges may be incurred.

(2) If a replacement vehicle is required as a result of an accident, You are responsible for making Your own way to the nearest Cheapa Campa

Branch or pick-up location as Your own cost. (3) Cheapa Campa may offer You the option of paying a "Replacement Vehicle Relocation Fee" to send a driver to deliver the exchange vehicle to Your location

(4) You will pay for any costs relating to delivery of a change over vehicle as a result of any vehicle accident. This charge applies irrespective of any liability reduction option taken.

# 19. General Provisions

- Immediately upon receipt. You must provide Cheapa Campa with every (a) summons, complaint or paper in relation to any accident or loss involving the Vehicle.
- You irrevocably release and hold harmless Cheapa Campa, its employees (b) and agents from all claims for loss or damage to personal property owned by You or others left in the Vehicle, or which is received, handled or stored by Cheapa Campa at any time before, during or after the rental period,
- whether due to Cheapa Campa's negligence or otherwise. Except as provided by law, You or passengers in the Vehicle are not (c) the agent, servant or employee of Cheapa Campa for any purpose whatsoever.
- Cheapa Campa gives no express warranties in relation to the Vehicle. Certain conditions and warranties are implied by statute, whether Commonwealth or State, which cannot be excluded, restricted or modified, such as those under the Trade Practices Act 1974. Where Cheapa Campa is permitted to limit its liability under those statutes for breach of any implied condition or warranty, Cheapa Campa limits its liability to replacement, repair or re-supply of the Vehicle. All warranties, conditions and other obligations which may otherwise be implied are expressly excluded by this Agreement in their entirety. Cheapa Campa is not liable to You or any other person for any indirect, special, incidental or consequential loss relating to this Agreement. In the event of no alternative vehicle being available to You Cheapa Campa's liability is limited to a refund of the rental charge or in the case of mechanical failure (unless caused by You) the remainder of the rental period.
- No right of Cheapa Campa under this Agreement can be waived except by (e) writing of an authorised officer of Cheapa Campa. A goods and services tax (GST) or any similar tax, stamp duty or any
- (f) other tax, a merchants fee, duty surcharge, levy or fee ('charges') may be imposed by local, state or federal government pursuant to this Agreement and collected by Cheapa Campa. In that situation, Cheapa Campa may in addition to the rental charge, recover from You an additional amount on account of the charges. Any additional amount on account of the charges shall be calculated without any deduction or set-off of any other amount and is payable to Cheapa Campa upon demand.
- You agree not to part with possession, dispose of, encumber or assign any (g) right or interest in the Vehicle and not create any lien on the Vehicle for repairs.
- You acknowledge that Cheapa Campa has not in any way represented itself to You as an entity carrying on the business of insurance, and nor (h) has Cheapa Campa made any recommendations to You, or given You any opinion or guidance in relation to any insurance product.

# 20. Illustration Disclaimer

Cheapa Campa's brochures, websites and other advertising material contain only representations of our vehicles. Pictures, illustrations, descriptions and measurements of the vehicles may be different to the actual vehicle offered to You due to modifications and/or upgrades. Cheapa Campa is not liable for such variance.

#### 21. Fuel

The Vehicle must be returned with the amount of fuel equal to that at the time of the commencement of the rental. If the Vehicle is returned with less fuel, the difference will be charged to You at a rate of \$5.00 per litre (which includes a service component)

22. Cleaning The Vehicle must be returned in a reasonable state of cleanliness or You may be charged a cleaning fee up to \$500. If applicable the toilet and waste water tank must both be returned empty or a \$150 cleaning fee will be charged to You in respect to each tank. The Vehicle must be completely free of mud. Smoking is not permitted in the Vehicles or a cleaning & deodorising process will be necessary at a charge of \$300.

#### 23. Branch Hours and Returns

All Cheapa Campa depots are closed Christmas Day, New Years Day, Good Friday and Australia Day Public Holiday (26 January 2015). All rentals picking up or dropping off on Anzac Day (25 April 2014) will incur an additional \$100 surcharge. All rentals picking up or dropping off on Boxing Day (26 December 2014) will incur an additional \$100 surcharge. Adelaide, Brisbane, Melbourne, Perth, Sydney depot hours are 8am to 4.30pm seven days a week except 01 May 2014 to 31 August 2014 where these depots are opened 8am to 4.30pm Monday to Saturday and closed on Sundays. Alice Springs and Cairns depot hours are 8am to 4.30pm Monday to Saturday and closed on Sunday except 01 May 2014 to 31 October 2014 where these depots are open 8am to 4.30pm seven days a week. Darwin depot hours are 8am to 4.30pm Monday to Saturday and closed on Sundays except 01 May 2014 to 31 October 2014 Darwin depot is opened 8am to 4.30pm seven days a week and closed from the 20 December 2014 to 28 February 2015. Broome depot hours are 8am to 4.30pm Monday to Saturday and closed on Sundays except 01 May 2014 to 31 October 2014

where Broome depot is opened 8am to 4.30pm seven days a week and closed from the 20 December 2014 to 28 February 2015. Easter Monday, Anzac Day, Western Australia Day and Queen's Birthday public holidays Broome depot hours are 8am to 12pm. The Broome depot is closed Christmas Day, Boxing Day, New Year's Day, Australia Day, Australia Day Public Holiday and Labour Day. All times are local times. The Vehicle must be returned at the Return Time and at the Return Location. If you wish to change the Return Location or the Return Date after the rental has commenced, You first must obtain permission from Cheapa Campa. Subject to the change of the Return Location being approved, an additional minimum charge of \$700 will apply. If the Vehicle is returned at a different location without permission, the cost of transferring the Vehicle to the Return Location will be charged to you, plus a minimum charge of \$700. You will continue to be responsible for the rental of the Vehicle, including demurrage, until the Vehicle is returned to the Return Location. If You return the Vehicle late without Cheapa Campa's permission, the Vehicle will immediately be reported to the police as stolen and You will be charged for the late return at a rate equivalent to double the daily standard gross rental charge for the Vehicle, plus the daily rate charge applicable to Your chosen Reduction Option. Early the Vehicle does not entitle You to a refund. return of 24. Rental Extensions

Should You wish to extend the rental period whilst on hire, you must first obtain authorisation from Cheapa Campa. This is subject to availability of the Vehicle. The extra cost of an extended rental must be paid by credit card over the telephone or at a Cheapa Campa Branch immediately on confirmation of the rental extension. The additional days will be at the daily standard gross rental charge for the Vehicle applicable at the time of the extension.

# 25. Cyclones/Flooding and Weather Conditions

Cheapa Campa is not responsible for road closures caused by cyclones, flash floods and other acts of God. Whilst Cheapa Campa will make every effort to accommodate delays and non vehicle returns to Return Locations for these events any costs over and above the minimum \$700 Return Date and Return Location fee will be your responsibility.

# 26. Kilometre Allowance

The Kilometre Allowance per day and Charge Per Excess Kilometre Fee is indicated on Rental Vehicle Agreement Part A. The applicable Excess Kilometre Fee is payable by You to Cheapa Campa on return of the Vehicle. 27. Satellite Safety Beacon

If You are supplied with a Satellite Safety Beacon it should only be activated in life threatening emergency situations to alert the rescue authorities. Deliberate misuse may incur a severe penalty. Any costs incurred due to the activation of a unit are a matter strictly between You and the rescue authorities

# 28. Damage Liability Redutcion

You will receive the benefit of Cheapa Campa's legal protection in respect of damage to the Vehicle or damage to any third party property other than any property owned by You (or any friend, relative, associate or passenger) or any property in your physical or legal control provided You:

- (a) have paid the minimum Liability Reduction set out in Rental Vehicle Agreement Part A
- are not in breach of this Agreement and have not caused any other person (b) to have acted in a manner which is in contravention of this Agreement;
- (c) are not covered under any other policy of insurance;
- have provided such information and assistance as may be requested (d) Cheapa Campa's Accident department and, if necessary, authorised Cheapa Campa's Accident department to bring, defend or settle legal proceedings, and have the sole conduct of those proceedings.

29. Personal Injury The Vehicle has third party personal injury insurance cover. It is likely that any other vehicle involved in the accident also has third party personal injury insurance cover as well. Depending on the circumstances of the accident, You may be entitled to claim for your personal injury against the third party personal injury insurance of the party which is responsible for the accident. Details of the third party personal injury insurer for the Vehicle are set out in the registration details of the Vehicle

#### 30. Property Damage

You will remain responsible up to the amount of the applicable Liability Reduction set out in Rental Vehicle Agreement Part A for the cost of such damage to the Vehicle and for damage to third party property. You will also remain responsible for the cost of demurrage for the period the Vehicle is unavailable due to repairs. The Liability Reduction applies in respect of each claim, not per rental. In the event of a claim, Cheapa Campa will require you pay a second bond equivalent to the applicable liability if You are continuing with the rental plus an administration fee of \$75 per claim

The Liability Reduction is applicable regardless of who is at fault and must be paid at the time the accident/incident is reported to Cheapa Campa, not at the completion of the rental period.

Note: Personal belongings damaged, stolen or lost are Your responsibility. Cheapa Campa recommends that You do not leave items of value in the Vehicle and that You take out Your own Personal Travel Insurance. 31. Liability Reduction

This Bond is payable to Cheapa Campa by an open signed credit card imprint with an authorisation obtained (sufficient funds must be available for \$250).

#### 4WD Camper Bonus Pack

The 4WD Camper Bonus Pack is only available with 4WD Camper hires and when Reduction Option 2 has been purchased. Subject to clauses 5c and 16 the 4WD Camper Bonus Pack extends the cover available for 4WD Campers to include

i) Accidental damage to the over-head and under-body sections of the 4WD

- Unlimited tyre and windscreen cover ii)
- Damage to Awning iii)
- Towing and vehicle recovery costs from 4WD roads where permission from iv) Cheapa to travel on these roads has been granted (see section 12c for a list of these roads)

This protection does not cover single vehicle rollover.

# 32. Bond

For security purposes, only a credit card can be used to provide a bond. When the bond is debited a non-refundable credit card administration fee will apply of 4.5% for American Express and Diners Club and 2% for Visa. MasterCard Visa Debit and MasterCard Debit. The credit card holder must be present and be able to sign for the bond upon collection of the Vehicle. The credit card holder is jointly and severally liable for any damage to the Vehicle. The bond is fully refundable when the Vehicle is returned to the correct location on time, is full of fuel and all other terms of this Agreement have been complied with. If there is damage to the Vehicle on its return, the bond will be used to cover the cost of such damage up to the amount of the relevant Liability Reduction. However, if the terms of this Agreement are breached and the bond is insufficient to cover the damage then any extra cost will be charged to You. Bond Roll Overs are permitted for Cheapa Campa multi hires within the same couontry when the bond is banked.

### 33. Privacy Notice
